**CLEO (Community Legal Education Ontario/Éducation juridique communautaire Ontario)** is seeking a Student Researcher ("Researcher") to support the development and maintenance of its <u>Guided Pathways</u>. Guided Pathways are A2J Guided Interviews that provide public legal information and help people to complete court forms, tribunal applications, and other documents by simplifying complex processes. The Researcher will also support an innovative project to use generative artificial intelligence (AI) in coordination with a new CLEO Guided Pathway.

This is a full-time, hybrid position (in-office 2 days a week and remote 3 days a week). It begins January 1 and ends April 30, with some flexibility. The Researcher will be paid \$24 per hour. No benefits are provided for this position. The Researcher will work closely with a small project team, as well as independently on discrete tasks, reporting to the Director, Guided Pathways. This position is intended for a full-time student who is seeking employment during the 2024 winter/spring semester, returning to class in the fall of 2024.

## Key responsibilities include:

- Editing and annotating decision trees that outline the question sequence and logic of CLEO's Guided Pathways in MS PowerPoint, as instructed.
- Reviewing CLEO's Guided Pathways to assess usability and conformity with decision tree outlines in MS PowerPoint, identifying problems and variances in written reports.
- Locating information from sources that include CLEO's <u>Steps to Justice</u>, and government, court, and tribunal websites, as requested.
- Learning basic functionality of A2J Author software to transcribe and format interview text from MS Word, according to approved scripts and style guides.
- Entering lists of assigned program variables into the database system that hosts the Guided Pathways.
- Creating and editing templates, checklists, and other reference documents to support the operation of CLEO's Guided Pathways through programming for user support, privacy compliance, evaluation, and research.
- Supporting the research and development of a proof-of-concept project using generative AI to help users of a new Guided Pathway draft narrative content for an affidavit.
- Assisting with the preparation of training and promotional materials, for example, creating slide decks for presentations.

- excellent written and verbal communication skills
- strong reading comprehension ability

Writing and research experience, as well as prior work with database applications will also be considered an asset. Some post-secondary education is required for this role. Only current students will be considered for this role.
